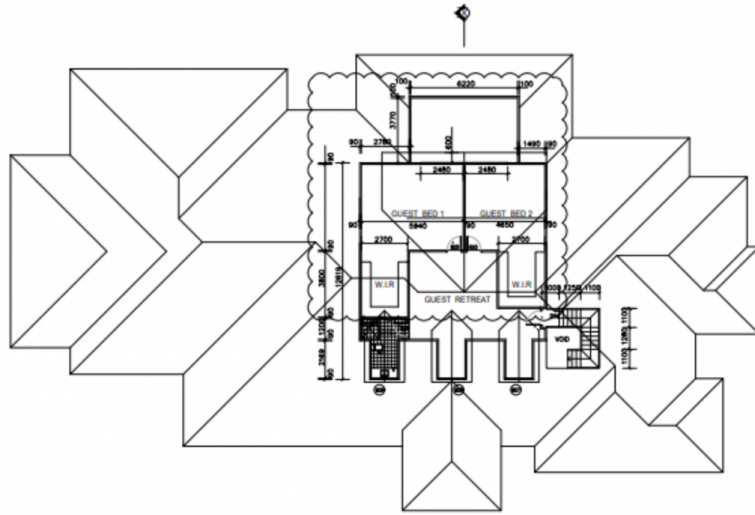

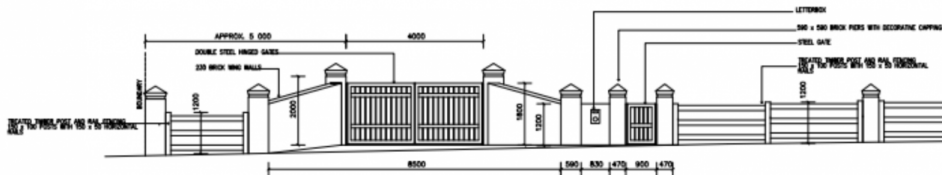

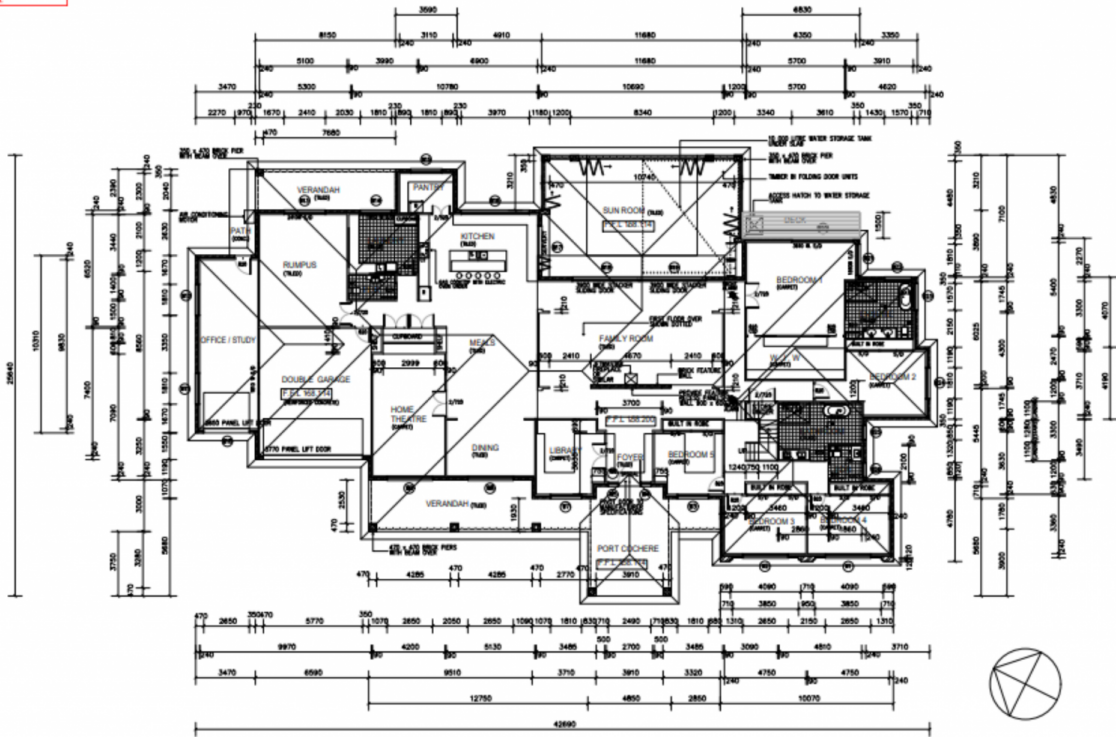


Front Fence Detail
